# Court tosses FCC 'wardrobe malfunction' fine

On Monday, July 21, 2008 the Third U.S. Circuit Court of Appeals out of Philadelphia threw out a \$550,000 indecency fine against CBS Corp. for the 2004 Super Bowl halftime show that ended with Janet Jackson's breast-baring "wardrobe malfunction."

The 90 million people watching the Super Bowl, many of them children, heard Justin Timberlake sing, "Gonna have you naked by the end of this song," as he reached for Jackson's bustier.

The three-judge panel of the 3rd U.S. Circuit Court of Appeals ruled that the Federal Communications Commission "acted arbitrarily and capriciously" in issuing the fine for the fleeting image of nudity.

## ADA Response:

- (1) Credit the FCC for attempting to do its job at that point in time. The FCC responded to the outcry of the American public. The FCC found CBS culpable. They fined CBS \$550,000. (Though even that figure is merely the cost of doing business for CBS Corp.)
- (2) CBS predictably appealed the ruling sending it to one of the most liberal courts of appeal in the country the 3rd Circuit Court out of Philadelphia.
- (3) It has taken four years of court pleadings and wranglings to come to this demoralizing decision.
- (4) This decision unfortunately further erodes the authority of the FCC in regards to enforcement of standards of decency for America's airwayes.
- (5) This decision is damaging, with potentially long term consequences. Yet it has no effect upon the ultimate authority

which all of us are under - whether or not you, I, CBS Corp or the 3rd Circuit Court acknowledge it.

Working under virtual anonymity, the prohomosexual empire of activist Tim Gill is growing at a frightening pace in both influence and capital. The Gill Action Fund, which helped to knock off several profamily candidates in 2006, is back with a stocked war chest and its sights set on a gay and lesbian takeover of the 5,000 state seats that may be "up for grabs" this November. Gill's success is the subject of a lengthy piece in The Advocate, a radical homosexual publication. "The Gay Mafia," as the cover calls them, were largely responsible for 10 state chambers switching hands from conservative to liberal in 2006, and the Fund is thirsty for more. In withdrawing from network television's most trashy show, Dannon gave no explanation. We only regret that it took so much persistence and insistence from so many consumers before they were willing to do what was right.

#### Religious Liberties the **Crosshairs**



Family Research Council held a standingroom-only panel discussion [July 10] about the California same-sex marriage ruling and its effects on religious liberty. Many religious organizations in California and elsewhere are worried about the possible erosion of their First Amendment rights and religious liberty protections. The panel addressed key issues being asked by religious organizations: Will churches be able to refuse to marry homosexual couples?

Will they be able to deny access to their facilities? ...

The reality is that the religious liberty of Americans is under fire, as evidenced by the loss of tax exempt status for a New Jersey Methodist organization that refused to allow lesbians to have a commitment ceremony at their site, and a lawsuit against a Christian photographer in Arizona who refused to take pictures of a lesbian commitment ceremony, to name just two examples. The panel also addressed the incidents in Sweden and Canada under their hate speech laws, including the prosecution of Swedish pastor Ake Green for speaking of homosexuality as a sin, and Pastor Stephen Boisson in Canada for the same offense. A part of the California ruling allows homosexual couples from out-of-state to travel there and get married. ....

#### Weapons of Mass. Destruction

The Massachusetts legislature is pulling out all the stops to recapture its title as the most liberal state in the union on marriage. [July 15], the Bay State Senate voted to repeal a 95-year-old law that former Gov. Mitt Romney enforced to prevent out-of-state homosexuals from "marrying." To justify the move, the Senate pointed to a report commissioned by the state that claimed non-resident "marriages" would bring in an estimated \$110 million. As groups like Family Research Council have argued, money can't undo the damage done to society by the state's campaign to expand homosexual "marriage."

Massachusetts liberals are hoping to throw open their borders to same-sex couples ... The region most likely to take advantage of the invitation is nearby New York, whose governor, David Paterson (D), made the unilateral decision to recognize out-of-state "marriages" without putting the idea to a democratic test. ... In a July Pew Research Center poll, only 15 percent of Americans surveyed "strongly favored" legislation that would "allow gays and lesbians to marry legally." # Flint, Michigan Police crack down on saggy pants



Recently the Police Chief from Flint, MI instituted a policy taking action against those wearing saggy pants that expose underwear or bare bottoms. He stated, "Some people call it a fad, but I believe it's a national nuisance. It is indecent and thus is indecent exposure, which has been on the books for years."

On June 27, the chief issued a departmental memorandum telling officers: "This immoral self expression goes beyond freedom of expression." Those in violation can be charged with a misdemeanor – either disorderly conduct or indecent exposure.

Restoration of decency begins with little things. It's quite evident where the idea of 'anything goes' is leading our society. Vulgarity is rampant in dress, language, behavior, entertainment. Kudos to a chief of police who in taking a stand against it!

Unfortunately, the ACLU would much rather see no limitations at all on vulgar expressions or behavior and is threatening to sue.

"We are confident that young men in Flint will contact us now that the chief has announced that he won't budge," said Michael J. Steinberg, legal director of the state ACLU. "If they do, we'll sue."

However, it may be the ACLU that is out of touch with what society accepts as 'civil' or a 'liberty'. Many have expressed support for a ban on saggy pants that expose nudity or underwear.

The Free Press article goes on to say: "We're going to keep doing what we're doing," [Dicks] said today. "I think people are catching on and pulling up their pants. I'm getting a lot of support from local parents and churches and the mayor said he supports me one thousand percent."...

The suburban Chicago village of Lynwood, Ill., passed an ordinance last week that states people caught exposing three inches or more of their underwear will be fined \$35.

"We need to stop this offensive and unsanitary behavior," said Lynwood Mayor Eugene Williams. ...

Williams said he salutes Chief Dicks.

"Tell the chief in Flint that I support him," he said. "And tell him to hang in there."

In Riviera Beach, Fla., more than 70 percent of the community's voters approved a measure in March that imposes a series of penalties on saggers with each violation. First-time violators face a \$150 fine. Third-time offenders could do jail time.

Terry Girard, an English teacher at Lawrence Technical University in Southfield, said she belongs to the ACLU, but can't back them on the saggy pants.

"I think the ACLU is dead wrong here," she said. "I see too many kids walking around like this. I don't want to see someone's underwear, and I definitely don't want to see their bare butts either." ... http://www.freep.com/apps/pbcs.dll/article?AID=/20080721/NEWS06/80721061

# Michigan university thumbs its nose at court

Michigan's Supreme Court ruled in May 2008 that the state's ban on gay marriage makes it illegal for public universities and other entities of state government to provide domestic partner benefits to the partners of homosexual employees.

Yet, Grand Valley State University (GVSU) is thumbing its nose at the state's high court, and is bypassing the essence of the court's ruling by instead

adding health insurance benefits for "unmarried couples". This benefit plan will apply to gay couples, as well as live-ins.

According to GVSU counsel Tom Butcher, the new plan is not simply same-sex benefits repackaged under another name. Right. To paraphrase an old adage, 'a rose by any other name...' (or in this case, skunk cabbage). GVSU may claim their policy is not a way to circumvent state law, but common sense tells us otherwise. Their policy weakens the institution of marriage while promoting immoral lifestyles. Just like the skunk cabbage, it smells like another attack upon traditional values.

According to a local news report:

"...State Representative Arlan Meekhof called the plan "A slap in the face to Michigan taxpayers and morality."

In attacking the school's board of trustees Meekhof released the following statement, "Not only are they increasing the university's expenses, but this institute of higher learning has chosen to use taxpayer dollars and student tuition dollars to allow and promote immorality."
