


## What happens when self-pleasure marks us. The brainwashing of America.

●Despite the rhetoric about "reducing the number of abortions," Liberals in Congress have passed a \$768 million dollar Financial Services Appropriations bill - without allowing debate - to fund abortions in the District of Columbia. Common sense should tell Congress that they cannot reduce abortion by funding it.

Taxpayers will be forced to pay for the destruction of innocent human life and other unacceptable programs in the District, including giving needles to drug addicts to use for illicit drugs. The bill (which President Obama supports) will legalize marijuana for medical use, eliminate school vouchers and stop funding for a drug prevention campaign. [Liberty Council, 7/21/09]

●A fast moving socialized health care bill is poised to "overhaul" the health care system. The President wants a bill on his desk before Congress leaves town for its August recess. The Democrat leadership apparently doesn't want time for public debate.

According to the Associated Press, the plan being pushed by House Democrats has a price tag of \$1.5 trillion; includes more than \$500 billion in tax hikes; and slashes Medicare and Medicaid spending by hundreds of billions of dollars. How is the government going to do all that without cutting services or rationing care? # Health care reform will lead to rationing

For months, the Blue Dog Democrats [a group currently of 52 moderate and conservative Democratic Party members of the United States House of Representatives] have asked their party leaders to be a part of the health care reform. But according to Rep. Mike Ross (D-Arkansas), chairman of the Blue Dogs' health care task force, these lawmakers have been shut out of the process just like their conservative Republican counterparts. So they made their concerns public and are now reaping the consequences.

Pro-life Rep. Bart Stupak (D-Michigan) says he has been "taken to the woodshed" by House Leadership for disagreeing with the health care reform bill. He and other Blue Dogs have serious concerns with the bill that simply aren't being addressed by their party leaders. They are working to ensure that Democrat leadership doesn't jam health care through Congress before their issues are resolved. The fortitude of the Blue Dog Democrats, particularly Members on the Energy and Commerce Committee, to cross their party's leadership and potentially derail the bill has provided an opportunity for Americans to find out what is actually inside this massive piece of legislation.

And what's included should terrify us all. This legislation will create a fundamental right to abortion in our health care system. Concerns about the Freedom of Choice Act (FOCA) were spot on - this health care legislation is FOCA by stealth. The health care legislation will mandate and subsid-

ize abortion coverage in American health plans, will nullify state laws that limit abortion, and require "access" to elective abortions, which will result in more abortion clinics.

The health care reform bill will lead to rationing. A government board will determine what treatments can and cannot be allowed. Pres. Obama says only people who will get "healthier" should get treatment - which theoretically excludes the disabled, the elderly, and others who bureaucrats decide aren't worth the cost. Many doctors, who will be forced to violate their consciences under this bill, are planning to leave the profession if it passes. This means all of us will have less access to every kind of health care.

Offering a "public option" virtually guarantees that people will move from private to public health insurance. A provision in the House bill would outlaw citizens obtaining new private plans after the public plan begins. Health care decisions will be taken out of patients' and doctors' hands and placed into the government's hands. The current health care reform bill also requires every individual to buy health insurance or pay a fine. Radical pro-abortion Health and Human Services Secretary Kathleen Sebelius would determine whether a particular plan would qualify.

This mandate means that cost-sharing arrangements, such as Christians who jointly pay for health care for families within their groups, could be forced to purchase a health insurance plan that violates their religious beliefs.


The overwhelming cost of the health care reform bill is staggering, especially when experts have predicted that current Medicare funding could run out within seven years. The Congressional Budget Office estimates that this reform package will cost \$1 trillion. Others estimate it to be \$1.6 trillion with \$800 billion in tax hikes and fees that could add as much as \$239 billion to the deficit.

The Blue Dog Democrats are now facing a full court press from the Obama Administration. They will be meeting with Presi-

dent Obama [7/22/09] and will likely face tremendous pressure to cave on their principles in order to pass this health care reform bill.

# Letter to U.S. Attorney General Eric Holder urging prosecutions

Dear Mr. Attorney General:

Greetings and congratulations on your appointment as attorney general. Since the advent of the Internet, illegal pornography has flooded homes, businesses, public libraries, and even schools. The results have been devastating to America. Pornography addiction is now common among men, women, and even many children. Children are creating cell phone child pornography, in a new trend called, "sexting." Pornography use is now a significant factor in divorce. Hotels, motels, cable and satellite companies, and other businesses are making tremendous profits by offering illegal, obscene pornography. America is becoming a "pornified culture," as author and *Time* magazine writer Pamela Paul has stated.

We are compelled to write to you and ask for an expansion of the Administration's efforts against the scourge of pornography. To discuss this issue further, we respectfully request to meet with you at the earliest opportunity.

We are heartened by your past expressions of concern about the spread of illegal pornography. In a memorandum of June 10, 1998, from you to all United States Attorneys while you were Deputy Attorney General, you said,

*"Thus, priority should be given to cases involving large-scale distributors who realize substantial income from multistate operations and cases in which there is evidence of organized crime involvement. However, prosecution of cases involving relatively small distributors can have a deterrent effect and would dispel any notion that obscenity distributors are insulated from prosecution if their operations fail to exceed a predetermined size or if they fragment their business into small-scale operations. ... Because of the nature of the Internet and the availability of agents trained in conducting criminal investigations in cyberspace, investigation and prosecution of Internet obscenity is particularly suitable for federal resources."*


We hope that you still share these same sentiments now that the problem of illegal pornography has become immeasurably worse. We urge you to continue to speak out publicly against illegal pornography and encourage U.S. Attorneys to fulfill their obligations under federal law and vigorously prosecute the purveyors of obscenity. We know the public would be behind you in this regard.

Thank you for considering the importance of this issue. We value your past efforts and accomplishments in the fight against illegal obscenity thus far and trust that we can discuss ways to partner with you on this crucial endeavor to further protect children and families. We are available to meet with you at your earliest convenience. God bless you, Mr. Attorney General.

(4) We have remained small over these years. We have always been able to pay our bills on time. We have missed a few pay days but with a very, very few exceptions have caught up.

(5) We have been members in good standing with the Evangelical Council for Financial Accountability (ECFA) since 1993. See: [www.ecfa.org](http://www.ecfa.org)

(6) It has become my prayer in recent months that God would see fit to place His touch upon an individual or more than one individual to lend support to this ministry through one of a variety of ways that some have found to use their resources to empower ministry while they are yet alive. Or, others are preparing wills, trusts, insurance plans that set aside money after they are gone.

We have greatly benefited from a few such gifts in recent years. We recognize each one as a special gift from special friends with a touch of God to give to us just when we need it most.

(7) We have recognized that we aren't in the business of orchestrating or forcing anyone's hand in any of these regards. For example, we are thankful to God for anonymous friends that so faithfully get behind us year after year via the match grant (we don't know where we would be without these extra helps that help encourage more giving.) They often generate \$30,000 a year for us.

## Burger King's Betrayal



In 2004 ADA contacted Burger King after one of its ads appeared on "Desperate Housewives". At that time Burger King immediately withdrew the ad and wrote a commendable letter. The company was led at the time by Gregory Brenneman, who, we discovered, was a Christian. Well, Mr. Brenneman no longer heads the company and the Burger King of today seems to have no qualms about wallowing in vulgarity - even with its own ads.

Burger King recently released a highly offensive ad in an overseas promotion. The graphic sexual nature of the ad is too crude to repeat here - suffice it to say that the ad blatantly and explicitly equates a BK sandwich with a perverse sex act. While this ad isn't currently running in the United States, the ad has spread across the country via the Internet, and Burger King has received exactly what it is looking for as a result - publicity.

However, as reported by [examiner.com](http://examiner.com), Burger King has also received much criticism - even within the advertising world itself. "Mark Duffy, an established advertising copywriter at a New York City firm stated to Fox News, 'I've seen a lot of sexual innuendo ads and this is about the worst, especially for something as mainstream as Burger King. I was a little repulsed by it. It's really misogynistic to women and it's also unappetizing.' Duffy later stated that the ad was among the worst he had seen in his 17 years in the advertising industry.

Scott Purvis, president of an accomplished advertising research firm in New Jersey ... [stated] that advertisements with sexually explicit material, or even simple innuendos are recalled by consumers 20 percent more often than regular advertisements. 'But the problem is, the [sexually explicit] advertisements, as a group are not as persuasive as all advertising,' he said. 'It stops and gets people's attention, but they generally don't go further and get any kind of motivation of interest in the product itself.'"
