The book, in part, details the heroics of European Christians who stood against the evil of the Nazi regime to protect their Jewish neighbors. As the author states: "The churches [in Holland] were not silent in the face of Jewish persecution. They urged their parishioners to resist it, no matter what the cost. As one pastoral letter put it:

We know what conflicts of conscience result for those concerned. In order, therefore, to eliminate all doubts and uncertainties that you may have in this respect, we hereby declare most explicitly that

no compromise in this domain of conscience is allowed; and should refusal of collaboration [with the Nazi domination] cause sacrifice to you, then remain steadfast in the certainty that you are fulfilling your duty toward God and man."

That sacrifice resulted in 20,000 Dutch Christians being sent to concentration camps for protecting Jews.

Think of that pastoral call to take such a stand no matter what the sacrifice! What would be the impact today if American Christians had the same mindset – to oppose evil and stand for Truth at any cost? If we were more committed to fulfilling our "duty toward God and man" than our own personal fulfillment and comfort?

If we stood so boldly, would one million babies be aborted each year? Would our legislatures and courts brazenly foist homosexual marriage upon state after state, with seemingly no concern for the will of the people? And would our culture be as saturated with
