America is clearly experiencing a time of chastening and trimming. Will we ever see a day of such prosperity again? Perhaps, but not likely any time soon.

As we are seeing, so much of the high living was based upon the practice of ungodly financial principles both as a nation and as individuals. Our government and banking institutions were fostering unwise financial decisions.

Each one of us finds ourself caught in the maelstrom to one degree or another. Some of you may have lost a job or been laid off or are in retirement but are living on a fixed and very tight income. We keep our expenses down including our salaries. We are members of the ECFA (Evangelical Council for Financial Accountability) We pay our bills in a timely manner. We have absolutely no debt on the building or anything. As I often say in our thank you letters, we are grateful to God for what He's done and for His faithfulness to us exhibited in so many ways including the gracious, generous and faithful giving that comes from a solid core of His people.

Speaking of the ECFA. It was recently pointed out to me that out of approximate-

ly 1 million Christian non-profits only 1,400 are members of the ECFA. We have been members of the ECFA since 1993.

In brief: ECFA is an accreditation agency dedicated to helping Christian ministries earn the public's trust through adherence to Seven Standards of Responsible Stewardship.

I'm writing this front and center in this month's newsletter because I just want you to know that we are trying to do our best to earn your trust, keep your trust, and be an open book as to our financial operations. [You can find out more about the ECFA at www.ecfa.org]

Nearly each day we receive little notes of encouragement. Today one supporter wrote: "Thank you for all you do! May God bless all your hard work." And another: "My prayer is with you and your staff as you carry on this important work." 
The Faithfulness of God and His call for us to be faithful, too - including with our finances

Hate Crimes at the State Level and Its Opposition

I spent the morning recently in Lansing, Michigan at the House Office Building across the street from the State Capitol.

In Michigan, the Democrats are the majority party on the House side 67-43. The House Judiciary is controlled by the Democrats 9-6.

Within the testimony given in regards to so-called hate crimes legislation, the most discouraging for me was the testimony of the Washtenaw County Prosecutor Brian Mackie, who spoke representing the Prosecuting Attorneys Association of Michigan, in favor of the Hate Crimes legislation.

I'm finding it difficult to believe that the Prosecuting Attorneys Association of Michigan is supportive of this package of bills HB 4835 and 4836 as I have had multiple conversations with prosecutors over the years - though in regard to opposing obscenity, a different issue.

I found Mr. Brian Mackie to be the most liberal prosecutor I had ever encountered, and I have visited with prosecutors from Grand Rapids, Grand Haven, Muskegon, Detroit, Flint, Bay City, Mt. Pleasant, Kalamazoo, Saginaw and Ann Arbor, etc..

Mr. Mackie stated at our meeting in 1994 that if he served as prosecutor for the next 30 years that he would never bring a case against obscenity because it was basically frivolous (pornography was victimless and a waste of his time).

Here were laws already on the books against obscenity, and Mr. Mackie stated he wasn't going to enforce them. This from the chief law enforcement agent in his county.

Now here he speaks representing the Prosecuting Attorneys Association of Michigan



on the subject of Hate Crimes.

\$10.95 will FeD-Ex a letter to each U.S. Senator urging a filibuster of the the "Pedophile Protection Act."

Most of you are aware of the forthcoming Hate Crimes bill more appropriately named the "Pedophile Protection Act" as it is being considered in the U.S. Senate.

It has already been passed by the U.S. House where it was sent to Sen. Patrick Leahy's Judiciary Committee.

Passage of this bill by the U.S. Senate would be reckless and irresponsible not only because of the "chilling effect" it would have on First Amendment-guaranteed rights to free speech, but also because it would provide, for the first time ever, special legal protections for pedophiles and other sexual offenders.

This bill would more appropriately be called "The Pedophile Protection Act."

For only \$10.95, any member of the public can send letters to all 100 senators, individually addressed and 'signed' by the sender. The letters ask for a written response and call for opposition to the bill, including by filibuster if necessary.

This opportunity is made available through Worldnetdaily. If you don't have access to the Internet, seek out a friend or loved one who can easily help you.

Pat Trueman gives warning regarding what may be coming



On Monday, May 4 we reported on the Supreme Court's ruling regarding the Janet Jackson, Super Bowl Indecency Case stating in part the following:

... Monday, May 4, 2009, the U.S. Supreme Court ordered the 3rd U.S. Circuit to re-examine its ruling in favor of CBS and directed this Circuit Court of Appeals to consider reinstating the \$550,000 fine that the FCC had earlier imposed on CBS over Jackson's breast-baring performance at the 2004 Super Bowl. ..."

Pat Trueman, former head of the Child Protection and Obscenity Enforcement Section, stated the following. [Keep in mind Pat has worked inside the Beltway with the highest courts in the lands, prosecutors, etc.. He has a legal perspective that few of us have.] This is very concerning.

Mr. Trueman wrote:

"The 3rd Circuit is a favored circuit for the ACLU and others opposed to decency and values. If the court takes up the issue of the constitutionality of the federal indecency law, I predict it will strike it down and the U.S. Supreme Court will agree, based on last week's ruling in FCC v Fox TV. Then it's 'Katie bar the door' for indecency and porn on TV!"

Obama's 'Common Ground' on Abortion is Killing Ground

South Bend, IN - President Barack Obama delivered a speech [Sunday] during the Notre Dame Graduation commencement ceremony that was rife with heretical views of Christianity.

"It is obvious from Obama's speech that matters pertaining to religion and moral issues are still above his pay grade," said Operation Rescue President Troy Newman. "As an ordained elder in the Presbyterian Church in America, I can say with conviction that Obama holds apostate views on the role of Christianity in the world and the moral issues that spring from those teachings such as, abortion, stem cell research, and other matters."

Obama told the 2009 graduating class of Notre Dame that of the problems facing the world today, "no one person, or religion, or nation can meet these challenges alone."
