Will God have mercy upon America once again?

A person whom I highly regard asked me recently, "What is the purpose of your ministry?"

I took him to our purpose statement:

- a) ADA is an overtly Christian organization whose positions on the nature of morality emanate from a biblical worldview.
- b) we believe that Christians are called to the pursuit of holiness in all aspects of their lives,
- c) that holiness demands of God's people that they be a light in a darkened world,
- d) that being a light in a darkened world does not mean selfish retreat from the world, but an activism within it that proceeds from love for our neighbor.
- e) the ADA seeks to provide those who would desire to be a light with the tools and resources necessary to be that light.

Now look at our front page. What does the Muslim Brotherhood in the White House have to do with being a light in a darkened world, holiness, or decency?

Let me share with you my thinking and concern on this important front.

(1) The Biblical ethic of decency has its foundation God's Word.

"Pursue holiness without which no man shall see the Lord." [Hebrews 12:14]

"Be holy for I am holy," says the Lord. [I Peter 1:15,16]

"I will place no wicked thing before mine eyes. [Psalm 101:3a]

- The Freedom of the Press
- The Freedom of Assembly
- The Freedom of Religion

This and so much more is what has made America "A City on a Hill," an exceptional nation.

In addition, the rule of law in America also gives underpinnings to such legislation as Miller v. California which is what prosecutors use to determine if videos, DVDs, magazines, are obscene and therefore prosecutable. It has been declared and upheld long ago by the U.S. Supreme Court that obscenity is not protected by the First Amendment. In other words, obscenity is not free speech.

This lays a brief groundwork for me to say what I am about to say.

At the core of my call into ministry is God's call for me to pursue holiness without which no man shall see the Lord.

Obama appoints Islamis-Sympathizer

Is the man the Obama administration appointed on October 4 as key investigator for the terror attacks in Benghazi an Islamist-sympathizer? According to recently published reports, the new chairman of a State Department's "Accountability Review Board," which is heading the federal investigation into the Benghazi terror attacks, has been accused of being an "apologist for Islamic terrorism who has a cozy relationship with Iran."

What's more, the man in question — former Ambassador Thomas R. Pickering — has

documented ties with the controversial group, the Council on American-Islamic Relations (CAIR). CAIR, of course, is a documented Muslim Brotherhood affiliate and was named unindicted co-conspirators in the Holy Land Foundation trial — the largest terror-funding trial in U.S. history.

To make matters worse, Pickering is also co-chairman of the board of George Soros' International Crisis Group who has ties to other Islamic organizations as well, including the National Iranian American Council (NIAC), which has been described as pro-Iran "front group."

NIAC lost what Matthew Vadum at FrontPageMag describes as "an important defamation case in federal court last month in which it unsuccessfully argued the group was not a tool of the Islamic Republic of Iran."

Pickering, who is a member of NIAC's advisory board, formerly served as Under Secretary of State for Political Affairs (1997 to 2000). He was featured in a report "Rise of the Iran Lobby," by former CIA officer Clare M. Lopez, who was recently featured on the Glenn Beck Program to discuss the motivations behind the terror-attacks on the U.S. diplomatic outpost in Benghazi.

Pickering's Islamic-connections came to light after a report by the Investigative Project on Terrorism was published, exposing what it called the "scores" of established, radical Islamists who met with senior administration officials over the course of hundreds of White House visits....

ABC's wickedly sensual, sexy and spine-tingling new drama about fulfilling our deepest desires, 666 Park Avenue, will air Sundays from 10:00-11:00 p.m., ET. ..."

In short, the show takes place in a creepy apartment building where the building's owner Gavin Doran, who is supposedly the embodiment of the Devil, makes deals with the building's residents to fulfill their deepest desires — in exchange for their souls. That is, until Doran/the devil is tired of toying with them and his victims then come to a gruesome end.

The premiere episode opened with one such sinister scene as one of the building's tenants who had sold his soul tries to escape the clutches of Doran. When he thinks he has, fleeing the building he falls to his knees exclaiming: "Oh dear God, I thank you!!" Only to be followed by hideous, demonic sounds as he is horrifically sucked back into the building to meet his death.

How interesting that ABC has the character praise God for his salvation, only to be conquered by the forces of evil. Is ABC, with its long history of ridiculing and

Glee's latest – one of the most concerning yet

We've given warning in the past regarding the explicit and degrading themes on the teen-driven show *Glee*. One recent episode was one of the most concerning yet.

The episode, entitled "Britney 2.0," was a revisit of the Britney Spears theme from a season two episode. As you probably know, *Glee* centers on a high school glee club and each week song/dance performances by the *Glee* club members are interspersed with typical high school drama and angst.

If you know anything about Britney Spears' illicit antics, pornographic music videos, and explicit song lyrics, you get the idea about this episode. One erotic song after another performed "Britney-esque" with, vulgar lyrics and dance moves explicitly simulating sex acts.

Remember this show is geared towards a teen audience and is widely popular both with teens and pre-teens. Keep that in mind as I give you a couple of examples of what aired on this episode of *Glee*.

One graphic song performed by the high school characters on this episode was the Britney Spears' song "Three" with lyrics promoting three-way sex while telling kids that "living in sin is the new thing." Here are a few of the lyrics:

... Merrier the more, Triple fun that way,
Twister on the floor, What do you say?
Are - you in, Livin' in sin is the new thing,
... Countin' 1, 2, 3, Peter, Paul & Mary ...
Three is a charm, Two is not the same, I
don't see the harm, So are you game? ...
Lovin' the extreme ... You and me, Or three,
Or four - On the floor!

Later, one character says: "I had my first three-some at (age) 7.

Another number performed to a Britney song featured an extremely lewd so-called dance, filled with graphic moves simulating sex acts, a male dancer groping a female and grabbing her crotch, etc. And yet another performance featured a high school girl in a skimpy costume wearing a bra-like top gyrating on the school stage for a school pep rally. The song she performed repeated the word "b—ch."

Glee also features two homosexual characters who have been in a "romantic" relationship; a new transgender student – he/she goes by the name "Unique; and a bisexual female student who began a lesbian relationship with another female student last season. One of these two bi-sexual/lesbians is now off to college while the other is still in high school. As they were talking long distance over a webcam via Skype, one asks the other if she has time to "Scissor Skype." "Scissor Skype" is urban slang for two lesbians simultaneously masturbating in front of a webcam during a Skype session.

These few examples certainly should prove that *Glee* is not fit for family viewing. Yet millions, including Christian families, tune in each week! And as they do, along with the catchy performances, they are catching the immoral value system put forth by the creator of *Glee*.

While millions of youth (and their parents) follow this pop culture phenomenon, it is encouraging to hear from readers that the information we provide has made an impact in their lives and their decision-making, such as this powerful account.

"I just wanted to thank you for writing the article on "Glee" ... I'm a Christian & I've been watching that show since it debuted last year. However, for quite awhile now I've been praying about if I should continue to watch it or not ... After reading your excellent article, I felt confirmation that the Lord was indeed

telling me to stop watching (i.e. supporting) it. I then felt led to send out an email (see copy below) to all my friends regarding "Glee" (& I included at the bottom your email that you sent out). I've received only positive responses from friends so far, thanking me for sending it out...one went so far as to say that she was going to post my email on Facebook! So maybe that'll help our cause. ...

"Thank you again for encouraging us Christians to "fight the good fight" & not lose hope or give up. I appreciate all the great work you're doing!"

This writer then went on to be salt and light herself, sending the letter below to friends, encouraging them to take a similar stand. Think of the influence if we each did the same!

"I don't know about you, but I loved "Glee" in the beginning because of my singing background. I was hopeful that this new variety/character-driven series would stand out from the rest & be a safe, clean show for families. However, the producers have increasingly gone over the edge re: homosexuality, sex, suggestive songs/dances, etc. with every new episode ...

"So now I choose to take a stand & obey God by NOT WATCHING THIS SHOW ANYMORE. I hope you'll join me. I have to admit that it was a hard decision because "Glee" really appeals to me, so I kept telling myself, "Well, maybe it won't be so bad next week." I realized how easy it is to get caught up in the excitement of a "song & dance" series like this, but God is teaching me more & more that we Christians (at the risk of being labeled "prudes") need to be ever mindful of what we allow to permeate our hearts & minds, & we should especially protect our kids. The media these days seeks to undermine our morals & get us so used to seeing homosexuality, polygamy, profanity & immorality as supposedly "normal" in day-to-day life & families that we become desensitized to it. And - sad to say - it's working...the devil is wearing us down.

Officer Sacked for Teaching Class on Radical Islam from World Net Daily



Military brass already under fire for embracing President Obama's repeal of 'Don't Ask Don't Tell' and lashing out at an anti-Islamic filmmaker is now facing more heat for targeting a highly decorated officer for teaching an approved class on radical Islam.

Lt. Col. Matthew Dooley is a 1994 graduate of the U.S. Military Academy and has received commendations for exemplary service over nearly 20 years of service.

However, Dooley's career is now in shambles because he was fired from his teaching position with the Joint Forces Staff College at National Defense University and received a negative officer evaluation report. His offense was teaching a course on radical Islam that was approved by the military years earlier, but the attitude changed when Muslim groups complained about the class.

"It was a course that had been going on at the National Defense University since 2004," Richard Thompson, president and chief counsel at the Thomas More Law Center in Michigan, told WND. "His superiors knew what the course was all about. The first time they evaluated him ... as an instructor there, they rated him outstanding, indicated that he should be moved as quickly as possible to a command position."

Thompson said Dooley was the most popular professor at National Defense University, and students specifically requested this class. He added that Dooley was never alerted to any problems with the class on radical Islam until Muslim groups complained and his military superiors suddenly punished him with no warning.

"All at once, out of the blue, because of an October 2011 letter that was sent to the Department of Defense by 57 Muslim organizations saying, 'We want all material purged of anything that is offensive to Muslims or Islam and that any of the instructors that used such training materials should be disciplined.'"

Thompson said instead of defending the course or even launching a fair investigation, the very top of the military's chain of command simply caved to the outside pressure.

"It's a result of that letter that Gen. Dempsey, chairman of the Joint Chiefs of Staff, came down, reached in and looked at that course because he got information from an individual that wasn't even enrolled in that class," said Thompson, who pointed out that Dempsey then held a televised news conference to slam the course and Lt. Col. Dooley without Dooley ever being notified.

"[Dempsey] publicly excoriated Lt. Col. Dooley, who had no opportunity to defend himself at that point," said Thompson. Dempsey also "indicated that what Lt. Col. Dooley did was offensive ... unprofessional and stopped the teaching of that course, ordered another review of all courses at the National Defense University" because of the complaints from Muslims.

Dooley is now engaged in the first stage of a two-pronged effort to exonerate himself and restore his career. Right now, he is appealing his negative officer evaluation in the military legal system, but Thompson said that effort is unlikely to succeed since Gen. Dempsey is publicly on the record supporting the negative review. So

Thompson and Dooley are preparing a federal lawsuit to reverse the negative review based on Dooley's free speech rights and the academic freedom provided through the university. Thompson said complaints about teachers or courses at National Defense University are normally handled by the provost. In this case, the provost was never involved since Gen. Dempsey acted so quickly.

As deplorable as Thompson considers the Army's treatment of Lt. Col. Dooley, he believes the actions of Dempsey and others demonstrate a deeper problem that threatens all Americans.

"Political correctness is ruining the effectiveness of our war-fighting machine," he said. "If we cannot accurately identify who the enemy is to our own troops we will ultimately lose that war."

Exhibit 1 in Thompson's argument is the 2009 Ft. Hood shootings, in which Maj. Nidal Hassan killed 13 people and wounded dozens of others while shouting praises to Allah.

"We had at the time knowledge of this major, American-born, who had gone off the reservation," said Thompson. "None of the officers above him wanted to say anything because they were afraid they may be branded as an Islamophobe. The FBI didn't want to investigate ... because they would not be considered culturally sensitive. As a result, American soldiers died and several were wounded, and that's the kind of political correctness that's going to destroy the war-fighting ability of our combat soldiers. That's what's so dangerous about that."- wnd.com

This article is an example of the twisted value system of our culture and government - when political correctness is more important than the truth, even in the area of national security. “I’m Barack Obama and I approved this message”

One recent episode of *The New Normal* could have ended with the line, “I’m Barack Obama, and I approved this message.”

The New Normal, as you may recall, is NBC’s new sitcom about a gay couple, Bryan and David, who are having a baby via a surrogate, Goldie. The cast is rounded out by Goldie’s 9 year old daughter as well as Nana, Goldie’s Christian conservative grandmother – which of course makes her character a bigoted, racist, homophobe according to the show’s creators.

The title of this episode was “Obama Mama” which might give you a clue as to the direction of the storyline. In essence, this episode was a free 30 minute Public Service Announcement for the Obama reelection committee.

David refers to Nana as “small-minded” and calls her the “blond Imperial Wizard.” Again, labeling Republicans as racists – this time equating conservatives with the Ku Klux Klan!

Later, at a dinner party where the table conversation seems to be taken directly from the Democratic party platform, Bryan points out to their group of liberal friends, “We have a real, live Republican at the table here tonight!” His “partner” David says, “Quick, everyone, show proof of American citizenship.” The group is incredulous and berates Nana for her conservative views, peppering her with questions such as, “So you think all Americans don’t have a right to affordable healthcare?” And when someone chokes on a sip of water David comments that if Romney wins, “then we’ll just have to sit here and let you die.”

Nana replies that she doesn’t want the federal government making choices “that are my choice to make.” To which the others gang up and respond: *“Unless it’s a woman’s right to choose. Yeah, or the right to marry whomever you love.”* Claiming, gay marriage is “a moral imperative.”

When one of their guests, who happens to be black, later admits that he is voting for Romney, *The New Normal* again portrays Nana as a racist, having her character state: *“Wow, a black Republican! You know I’ve heard stories, I just never knew they were real.”*

The show ends with its most blatant piece of propaganda yet when Goldie’s 9 year old daughter participates in a mock election at school. When David and Bryan ask her who she voted for, she replies: *“I was leaning Romney for awhile ... but Obama believes gay people should be treated like human beings and you guys are gay so that made me vote for him.”*

Incredible! This is the ultimate in bigotry – NBC and *The New Normal* creator Ryan Murphy telling millions of viewers that Romney - and in essence all Republicans - don’t think homosexuals are human beings???

Even many viewers on the left see this show as blatant propaganda. Entertainment Weekly asked: *“... Can you believe NBC aired such a pro-Obama episode? Do you wish Ryan Murphy would go for more laughs and fewer Lessons? ...”*

- I am confused was this a sitcom or a 23 minute Obama ad. (For the record, I’m Team Obama ...)

- First of all, I want to say that I believe in everything this show stands for...that’s why I wanted to watch it. I support LGBT rights and will be voting for Obama all the way; ... However, I have decided to stop watching this show. It is WAAAY too preachy and Ryan Murphy makes it sooo obvious that he wants to push his political and personal agenda...

- This show is absolutely terrible. This will be the last time I turn in for Ryan Murphy’s lessons of the week. We get it. You love Obama, Republicans and Christians are pure evil, and everyone should be gay. Point taken.

- I could only watch 10 minutes of this show last night. Not everyone has the same political views. ...

- I say this as a white Obama voter... Tonight’s episode made me uncomfortable. The whole dinner party scene was too much for me. This show has such potential, but Ryan Murphy needs to cool his jets with his preachy lessons and the intense amount of bigotry from Nana ...
