I met with dear friends at the Faith Lutheran Church in Troy (Sept. 13), Covenant Presbyterian Church in Fenton (Sept. 15), Arnie's Restaurant in Grand Rapids (Sept. 16) and at our headquarters in Fremont (September 17). I also traveled to Lansing to the large Mount Hope Church. However, with no one showing up I met with a staff person who was very gracious in receiving me and my information, and, passing it along to one of the pastors.

Observations. I came away hugely encouraged as it was clear that what God was laying on my heart resounded in the hearts of every person in attendance. In addition, sacrificial gifts were also given demonstrating heart and spiritual evidence that God was at work.

People recognize that it is late in America. There is heaviness of heart regarding the spiritual falling away that we have been witnessing in our great country. There is a realization that if the salt loses its savor



wherewith shall it be salted. (Matthew 5:13)

Enclosed in this newsletter is a copy of the letter that is being sent to pastors.

We state in our important letter: This upcoming project (detailed below) is not affiliated with any denomination; rather it is calling out to all pastors who name the name of Christ and preach His Word. The project has the full support of Donald E. Wildmon (founder of American Family Association), Gary Bauer, President of American Values, Mat Staver (President of Liberty Counsel), Tim Wildmon (President of American Family Association), Art Ally (President of the Timothy Plan), and Dr. Ron Workman (Founder of Interim Ministries Incorporated).

In the early years of my becoming a Christian, I naively thought that most Christians would be like Dr. James Dobson or Donald E. Wildmon. I wanted to believe that you could count on a Christian as being someone that was on fire for the Lord and for His righteousness.

As the years passed and I began my full-time ministry as the state director of the American Family Association of Michigan, I was quite jarred by the ever evident reality that when I spoke before various church gatherings that it was always only a few that responded enthusiastically for our call to "pursue holiness without which no man shall see the Lord." Only a few would come up to our information/resource table afterwards.

I also began to realize quite some time ago that just because persons don't respond enthusiastically to our ministry and to the need for "salt and light" engagement doesn't necessarily mean they are not a Christian or that they are "asleep at the switch." There are ministries that just don't touch my hot button. I wouldn't want want Christians to think that I was "out of the will" of God because I didn't sign up for their newsletter or get involved in their good ministry.

However, that being said, I must say what a joy and an honor it is to be around likeminded Christians with similar callings.

Years ago I remember going to a conference in Grand Rapids with the featured speaker, former Fulton County (Atlanta), Georgia Solicitor General Hinson McAuliffe, addressing a good-sized gathering of activists. His comments have stuck with me long afterwards.

During McAuliffe's tenure in Fulton County, he personally led the charge in closing down a multitude of porn shops in that heavily populated area.

McAuliffe stated that some of the finest, most committed Christians he had ever met were those who hungered for righteousness and opposed pornography.

McAuliffe may have been biased as I am, but I echo those sentiments. This was reinforced again today and most every day as it was recently when I met with a core of people across Michigan.

How thankful I am to be a Christian! How thankful I am to have so many people standing with me, beside me, behind me, in front of me!

Today I received a call from a friend in the greater Detroit area. Her voice, as always, though I hadn't spoken with her in perhaps ten years, still had that ring of hope, resolve, concern, and endurance in the Lord, reflecting the power of God in her life and bringing that sense of joy and engagement in living out her faith in Jesus Christ.

That's what I saw at each stop along the way - person after person. I was encouraged and strengthened as I have been so many times.



### Thick as Thieves - NBC and Playboy

NBC recently premiered the show *The Playboy Club*, based on Hugh Hefner's 1960s Chicago Playboy Club. The TV show drew much outrage months before it was broadcast both from the right and the left – pro-family groups, anti-pornography organizations, and feminist Gloria Steinem.

While NBC aired steamy promotions in the weeks before the premiere, they tried to claim with a straight face that the show *The Playboy Club* was not a promotion of pornography or a promotion of the actual Playboy magazine and brand.

Yet not only is the Playboy name and logo peppered throughout the show, Hugh Hefner himself was used as a narrator for the initial episode. Hefner has eaten up the free publicity NBC is offering from this show, hoping to reinvigorate his aging brand overshadowed by the proliferation of internet porn. In return, Hefner has given NBC a quid pro quo, using one of the actresses from NBC's The Playboy Club as the "cover girl" of the October issue of his pornographic Playboy magazine - released to coincide with the premiere episode of NBC's raunchy new show. NBC and Playboy are as thick as thieves in their promotion of pornography.

The first episode began with this narration from Hefner: "...I built a place in the toddling town — a place where everything was perfect, where life was magic, where the rules were broken, and fantasies became realities for everyone who walked through the door...."

While Hefner describes The Playboy Club as a place with no rules, the show's creator, Chad Hodge, has stated that viewers will enjoy *The Playboy Club* as a guilty pleasure

and claimed, "Today, people wish we were living in unhealthier times." "Watching this pilot, people are always like, 'I wish I could smoke and drink and have sex in the bathroom'. …"

His description – smoking, drinking, and having sex in the bathroom – pretty much sums up the first episode. Along with lots of flesh, eroticism, and degrading references to women. I guess the fact that the show is set in the early 1960s, the producers must feel America will turn a blind eye in 2011 to women being overtly demeaned.

The show sends the message to male viewers that women are nothing more than sex objects for their pleasure – which is how the "bunnies" are portrayed – it tells female viewers to use their bodies to gain acceptance. In the first episode the Playboy "house mother" instructs the girls on showing more cleavage, more leg – more of everything – to appeal to men. Teaching the ploys of seduction.

The first episode ended with this narration from Hefner about the 1960s Playboy Club: "the world was changing and we were changing it – one bunny at a time."

Tragically, there is much truth in that. The proliferation of pornography of which Hefner was a major factor has changed the world for the worse.

The Playboy Club is set in the early 1960s – when pornography was still taboo and men needed a key to enter the world of Playboy. Now 50 years later pornography is available to anyone and everyone at a click of a button and the Playboy brand is even displayed on products at local supermarkets – such as at the regional shopping giant in our area, Meijer's, with their sale of Playboy brand men's toiletries.

And now NBC is jumping on the band wagon with a show that doesn't just refer to pornography, it doesn't just promote pornography – it is pornography!

And the corporations advertising on *The Playboy Club* are complicit with their sponsorship of the show. Companies

that depend on families for support are undermining the values of those same families. Advertisers such as Jell-O, Campbell's Soup, Hellman's mayonnaise, Chrysler, Sprint, Subway and others empowered *The Playboy Club* on NBC.

Please join with us and let these advertisers know that a company that aligns with the promotion of pornography will not be a company your family will support.

## CRASS OVER CLASS - ACTION NEEDED



In recent days we've received several notes and emails regarding a mall window display of a group of topless women – not at Victoria's Secret – but at the plus size women's clothing store, Lane Bryant.

One supporter first alerted us to this blatant display in the Lansing, MI shopping mall. Another person wrote: A week or so ago I was in the former Eastbrook Mall [now Centerpointe Mall, Grand Rapids MI] and was shocked with the window display of Lane Bryant's Store of topless women looking overly friendly with each other. Have you observed that?

And this email: I received the newest Lane Bryant catalog in my mail... this was the cover. [Same as mall display photo] I was embarrassed to pull this out of my mailbox. Some people are calling this art - I call it porn. I called and wrote to Lane Bryant.. maybe others would want to also.

After receiving the first message we stopped in at the mall and saw what the outrage was about - and it was certainly warranted!

The ad shows five topless women, wearing nothing but the jeans, the product supposedly being advertised. The women are standing in a row, erotically pressed up against each other, touching each other.

Lewd and disgusting are two words that came to mind when I saw this large window display. What is entering the minds of children when they pass by with their parents?

What do nudity and allusions of lesbianism have to do with selling jeans? Nothing. Lane Bryant's advertising ploy, following in the footsteps of Victoria's Secret, throws public decency out the window in their attempt to portray their brand name as "unconventional." These erotic displays

show complete disregard, even contempt, for mall customers. Shoppers are exposed to explicit images - without choice. Malls should be a welcome place for families without having nudity and sexual imagery foisted in our faces and in front of our children.

Moms and dads, grandmothers and grandfathers – all of us - need to oppose indecency/pornography wherever it is found – certainly that includes the local mall. If we stick our heads in the sand instead of taking a stand, such displays will only continue to gain acceptance and spread from Victoria's Secret to Lane Bryant to store after store – turning a family shopping place into a haven for eroticism and pornography



## **Tearing Down Imaginary Walls**

The first line of the First Amendment to the Constitution of the United States has caused a considerable amount of controversy. In fact, there was even concern regarding the meaning of the amendment ten years after it was added to the Constitution.

In answer to a letter from the Danbury Baptist Church which expressed concern that religious freedom was treated not as a human right but as a favor from the state, Thomas Jefferson wrote in 1802 to assuage the congregation's anxiety with the following words, which have since been warped to mean the opposite of the original intent: Believing with you that religion is a matter which lies solely between Man & his God, that he owes account to none other for his faith or his worship, that the legitimate powers of government reach actions only, and not opinions, I contemplate with sovereign reverence that act of the whole American people which declared that their legislature should "make no law respecting an establishment of religion, or prohibiting the free exercise thereof," thus building a wall of separation between Church and State.

It seems as if Jefferson wrote the line, the legitimate powers of government reach actions only, and not opinions, in answer to a line in the Baptists' letter which said ... no man ought to suffer in name, person, or effects on account of his religious opinions--that the legitimate power of civil government extends no further than to punish the man who works ill to his neighbors.

In other words, what Jefferson was saying was that when the Constitution said, "Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof," it meant that the religious beliefs of those in power must not affect the right of their constituents to

abide by their own beliefs. The only duty of government in terms of religion is to ensure that no man harms another man by way of practicing his religion and that no man prohibits another man from practicing his religion.

What the First Amendment was written to prevent is as simple as the words it consists of

Many of the original settlers who came to the United States did so to escape the persecution of the Anglican Church, the official church of England. At that time, the English government did not allow belief in any other religion or denomination. To prevent this, the framers of the Constitution made the matter of religious freedom the first point of the First Amendment to the Constitution: "Congress shall make no law respecting the establishment of religion, or prohibiting the free exercise thereof..."

That is a far cry from the modern interpretation of the First Amendment. Far from enforcing a "wall of separation between Church and State" as Jefferson intended (which was that the state would leave the church alone), the government has used the "wall of separation" argument to establish atheism as the state religion of the United States.

After all, you can't have a value neutral government. Either all belief systems will be treated equally, or one belief system will be preferred above the rest.

And the preferred belief system pushed by the government at this point is atheism or, more accurately, Secular Humanism.

Why do I say that Secular Humanism is the established religion for America in 2011? Here's how Merriam-Webster defines humanism: "a doctrine, attitude, or way of life centered on human interests or values; especially: a philosophy that usually rejects supernaturalism and stresses an individual's dignity and worth and capacity for self-realization through reason."

Secular Humanism simply takes away the "usually" qualifier for "rejects supernaturalism" in the above definition.

An example would be the public school's refusal to teach creationism as well as evolution. Most scientists will say that is because religion and science don't mix, but in reality, many scientists not only don't look for evidence of God, they reject any evidence that might point towards Him. And refusing to accept evidence is not science, it's ideology.

Secular Humanism is not an alternative to religion. It is simply an alternative religion.

This is why the twisted "separation of church and state" argument cannot work. In fact, it completely violates the actual meaning of the first amendment. This is what it comes down to: If the government "builds a wall" to protect itself from all theistic beliefs, it inherently sponsors Humanism. However, if the government "builds a wall" around the church to protect religious belief from government meddling, it can treat all religions equally.

The fact is, the issue comes down to this question. Does the "right" of someone to not be offended by a cross in a cemetery or a prayer in a school trump the right of someone to practice his religion.

The answer has to be no. It is not the job of the state to keep us from offending each other anymore than it is the state's job to tell us what to believe, and were the words of the First Amendment to be examined in their own merit, rather than the unfortunately worded letter of Thomas Jefferson, the argument against everything from prayer in the classroom to the Ten Commandments at the courthouse would be left without a leg to stand on.



## **Dignity or Degradation?**

If you have family members who lived through the Great Depression in the 1930s, you've probably heard accounts, as I have, of great hardship, yet great ingenuity to provide for one's family. Mothers scrimped and saved — everything! Clothes were patched over and over again. Families who'd lost jobs moved in with relatives. Those who had something to spare shared with those who didn't. Yet through great deprivation, pride and self-respect were traits that characterized that generation — and still do today.

Those who came through those troubled times did so with dignity and honor as they found ways to make ends meet. Their values weren't altered by hardship. Right was still right and wrong was wrong.

Today we also face very tough economic times—though not nearly with such hardship. Today there is a much greater safety net for those struggling. Between many forms of government programs, unemployment benefits that extend for nearly two years, home-heating assistance, etc. — as well as countless charitable organizations, food pantries, church outreach programs, thrift shops, ministries and missions — there are many sources of help for those struggling.

I'm sure the values of that generation from the Great Depression are also shared by many impacted by today's economy. However, that's not what MSNBC chose to highlight in a recent article posted on their website, entitled: "Lawyer turns topless dancer to pay bills."

The article paints a picture of a woman who graduated from law school ten years ago, but lost her job and can't find another in the legal profession and is now saddled with debt and student loans and – according to the article – has no other option but to dance naked to pay the bills.

She states in the article: "As a little girl, I never thought to myself, I just want to grow up and be a stripper," or, 'All I ever wanted to do in life is climb in the lap of sweaty stranger and take my top off."

"But, with our economy the way it is, especially in smaller cities ... you strip or you starve," she said.

Really?? There are no other options for young women in financial crisis, but to degrade and prostitute themselves to keep from starving? This is the message MSNBC is articulating.

The woman, referred to as "Carla," goes on to say: "... it's degrading and I hate it, but it is necessary right now and I'm glad I have the option of doing it," Carla said. "My parents and a few friends know and they were horrified at first. But now they are proud of me for sucking it up and doing what I have to do."

What parent would be proud that their daughter is working as a stripper?

MSNBC also points out how supposedly lucrative stripping can be. On an average day, she earns \$20 an hour, but on a good weekend night, she might pull in \$50 an hour –enough to get her finances back on track.

Carla, for the most part, attempts to paint a rosy picture of her experience as a stripper, claiming:

... "While there are some real creeps that come in, there are also some very sweet guys who are regular customers and who I genuinely enjoy knowing. ...

"... I have learned that I still have a lot to learn about life but now I have some incredible female mentors who continually inspire me with their courage and work ethic."

However, the article does give a hint about the actual horrors women in the sex industry face, stating: ... Carla said she has had her share of ugly moments. Not all men follow the rules; some have tried to overpower her and "grab her, bite her, kiss her, or get their hands under the bottoms (I) wear." ...

"I've had men overcome me," she said. "Luckily help has arrived and nothing has happened. But I have been scared."

This is the true picture of strip clubs. In the 1990s our ministry worked to strengthen Michigan's Obscenity Laws and bring more stringent regulation and limitations of sexually oriented business. Numerous legislative hearings were held in which the pornography industry brought testimony opposing the legislation and our side brought testimony in favor of the proposed regulations.

Through this process we communicated with a ministry friend from Citizens for Community Values in Memphis who led a ministry – the first of its kind nationwide – offering assistance, mentoring, and a way out for young women in the sex industry.

Several of the young women, former strippers, who had been helped by this ministry volunteered to testify at our state legislative hearings. They wanted their stories told of the horrors that take place in sex shops – the prevalent drug use; the sexual abuse of women by patrons; the coercion by management to participate in lewd acts; the employment of underage girls. This is the reality of strip clubs.

MSNBC may irresponsibly portray the sex industry as a positive vocation choice for out-of-work lawyers and financially troubled young women, but that is not reality.
