### A success story in a rural township near the Michigan state capital

Several years ago I received a call from a woman who was concerned that her husband was frequenting a sex shop in Grand Rapids.

My wife Jan and I met with her and another concerned lady. They wanted to know for themselves what was going on in this particular place.

Jan and I spent time in prayer and discussion with them and assisted in investigating the activity taking place.

The sex shop offered lap dances and couch dances, even though these had already been ruled illegal by the Michigan Supreme Court. (Michigan, State of v. Dizzy Duck (Mich, 535 NW2d 178, 449 Mich 353; March 1994)

The ladies were appalled and heartbroken over what they saw. Concerned, they took action. At that time, the victory that together we sought wasn't secured. The battle goes on.

Nonetheless, these are important battles and there are victories.

I have always been thankful to meet with people and stand with them as they do battle when their local township is threatened by someone seeking a special use permit to set up a sex shop.

In recent months, there was such a threat to Eagle Township in Clinton County, Michigan (just west of Lansing, MI).

As citizens became aware, numbers rose up attending an Eagle Township meeting. The meeting hall was filled to overflowing as one person after another spoke up and against the prospects of having a sex shop come to their rural township.

This was followed a week later with the meeting of the Clinton County Planning Commission. Every seat was filled. It was standing room only.

Any thought that activism is dead was dispelled that evening. More than thirty well-articulated testimonials were delivered supportive of decency, community values, family, the standard of God.

We even heard testimony from the Mayor of Grand Ledge, which is located in an adjoining county. He testified because the location for the would-be sex shop is a main thoroughfare for people from his community.

Others testifying were (in short):

The President of the Grand Ledge Board of Education. She stated that the school board voted earlier in the week urging the Clinton County Board of Commissioners to deny the request for a special use permit.

A teacher in the Grand Ledge Public Schools, etc., etc.

I discovered that he is an elderly man (81) on the last months of his last term in office as township supervisor.

And within another sixty minutes, Jan and my youngest son Chris (19) and his girl-friend Stacey headed out to be with our family in Pennyslvania.

In the midst of the horror, the hysteria, the grief, I saw a family rally around one another, praying and trusting God, even through this heart-wrenching loss of our beloved little Cassie.

Cassie, who had been born as a preemie baby at 1 pound 13 ounces and who required months of professional care and 24 hour care 7 days a week for several months after her birthday on May 5, 2007.

Cassie, whose little arms and legs were so delicate that you could put a wedding ring on the thickest part of her upper leg.

But little Cassie made great strides as she was nurtured and nourished by her mommy and daddy and her big sisters Jenna (5), Allysa (4) and her big brother Brandon (7).

What a sight to behold as she was hugged and loved on and held by her young siblings who had been coached very well how to be tender and careful.

Life can be so cruel. But God is good. He is truly glorious and ever loving and gracious. We must never forget that His ways are not our ways.

And in sorrow there is comfort - as family and friends and people whom we don't even know pour out their love through prayers, hugs, tears of compassion. As a stranger who came to the door as I'm writing this with an angelic figurine and with a sympathetic heart and touch.

And as members of our families rallied together around Jenny and Chris and lovingly stood together with them as they made decisions We are seeing right before our very eyes the marvelous grace of God poured out, giving each of us His peace, His love, His patience, His endurance. "... The play, which critically examines Bible passages about homosexuality, sold out a three-week run. Stephanie Sandberg, Calvin College theater professor, is the director of 'Seven Passages.'"

Calvin College, a college that once held true to God's Word, is increasingly demonstrating before a watching world that it has lost its spiritual moorings. Now they give a free pass to a play designed to help foster accommodation to perversion.

Quoting from an article in the <u>Kalamazoo</u> <u>Gazette</u> on February 3, 2008 we see that the premise of the production is to attack the Word of God and to make it say what they want it to say through seriously flawed translation practices.

"... The title refers to seven biblical passages that, according to Sandberg, 'have traditionally been used to oppress gays and lesbians and possibly transgender people as well.'

Sandberg cites Jude 1:7, which condemns the residents of Sodom and Gomorrah for 'seeking after strange flesh,' and Romans 1, which describes 'vile affections.' The New King James translation of Leviticus 20:13 states that 'if a man lies with a male as he lies with a woman, both of them have committed an abomination. They shall surely be put to death. Their blood shall be upon them.'

Sandberg said she and her cast 'looked at those passages as an issue of translation equaling oppression. ... I looked at different readings of them, as opposed to the traditional.'..."

### Boycott McDonalds by Bill Johnson

Tony Perkins of Family Research Council reported: Despite a boycott, McDonald's is showing no signs of reconsidering its partnership with the pro-homosexual crowd. In fact, rather than distance itself from the Human Rights Campaign (HRC), the multibillion dollar company is increasing its support. In a television commercial, the fast-food chain went so far as to express "pride" for being recognized by the HRC as a company that "actively demonstrates its commitment to the gay and lesbian community." Until McDonald's shows its commitment to American families, [mv wife] and I have eaten our last Big Macs. We refuse to let a single penny of our money fund the campaign to redefine marriage and sexuality.

#### **CBS Promotes Perversion**

"The cover page on <u>Advertising Age</u> July 7 is 'ADVERTISERS DON'T PARTY WITH CBS's SWINGERS.' Advertisers are staying away from advertising in Swingtown for fear of the backlash from consumers. The show is filling up its ad time with cheaper and self promoting CBS ads, fluff bits that aren't paying adverts. Proctor & Gamble, the 'largest' CBS advertiser, won't run any ads on Swingtown. So, tell your folks to redouble their efforts."

Most recently, Ace Hardware quickly pulled their ad after it appeared one time on "Swingtown", stating:

"Thank you for contacting us regarding Ace's advertising on the CBS prime-time show, "Swingtown."

When the media buy was placed for the show that aired Friday, August 8, we were unaware of the questionable content that would be included ... we have made the decision to permanently cease all advertising on this particular CBS show, effective immediately.
