


## President Obama joins with homosexuals in effort to strike down DOMA

Obama would later adapt his position because “strategically,” he understood that Republicans would use his radical support for homosexual “marriage” against him. ...**

As the nation is focused on the debate over healthcare reform, another front in the cultural battle is heating up regarding the defense of biblical marriage.

On August 17, Gary Bauer gave this report: “There are several lawsuits pending in federal court seeking to strike down the 1996 Defense of Marriage Act (DOMA). In legal briefs filed today, the Obama Justice Department clearly put itself on the side of those seeking to declare the law null and void. While the Administration begrudgingly acknowledged that it was obligated to defend federal laws, including DOMA, it is doing so in this case only half-heartedly. With a wink and a nod to sympathetic judicial activists, Justice Department attorneys told the court, “The administration believes the Defense of Marriage Act is discriminatory and should be repealed.” The Obama Administration is begging the court to strike down the only federal law that protects the citizens of 30 states who have voted to protect the traditional meaning of marriage.”

President Obama is joining forces with homosexual activists to get the Defense

of Marriage Act struck down. Just over a month ago President Obama made clear to a gathering of homosexuals at the White House that one of his priorities is to overturn the Defense of Marriage Act. DOMA, which became law in 1996, prohibits the federal recognition of same sex marriage and gives states the right to refuse to recognize same-sex marriages performed in other states.

In a case before the federal courts, the Justice Department filed a brief that states the Obama administration “does not support DOMA as a matter of policy,” and “believes that the Act is discriminatory and should be repealed by Congress.” In a written statement, President Obama states that he has “long held that DOMA prevents LGBT [lesbian, gay, bisexual, transgendered] couples from being granted equal rights and benefits.” In fact, as a U.S. senator representing Illinois, Obama stated his support for “the complete repeal of the Defense of Marriage Act.”

In a report by OneNewsNow, Alliance De-

fense Fund attorney Brian Raum had this response. “It’s really troubling that the federal government has taken a position that federal policy is bad policy,” says [Raum]. “Federal DOMA was passed overwhelmingly and represents the prevailing view of the people of the United States that marriage is between a man and a woman and that’s the optimal environment for raising kids,” Raum contends.

According to Raum, DOMA also provides protection for states. “Well, federal DOMA makes it clear that states have the right to regulate marriage within their borders and that they cannot be forced to recognize same-sex ‘marriages’ from some other states,” Raum explains. “If federal DOMA were to be struck down, that whole area of the law would be in jeopardy.”

In other words, even the 30 states which have ratified amendments to their individual state constitutions defining marriage as between one man and one woman could be forced to recognize homosexual “marriages” – overriding the will of the people who have overwhelmingly passed voter-

### A new web page - hacked and lost - symbolic of the battle of life

At the end of last year, we made the decision to upgrade our website. We sought outside help from a good ministry friend and former AFA guy to develop it for us.

Several months later, it was published. At that point our staff, including me, spent hours putting our archives into it - battle material: Victoria's Secret, indecency at checkouts, Abercrombie & Fitch, immodesty concerns, our battle regarding Howard Stern, etc.

We had perhaps hundreds of hours into it. Then as a result of an email alert that we ran regarding the possibilities of a nude beach being launched in Florida (and urging people to email Key West City commissioners), we were attacked by hackers from several sites throughout the U.S. and our website was knocked down. There were backups of it so momentarily we felt secure. Yet, through miscommunications, almost everything was lost including the many, many hours. We continue to build it back up as we are able.

When I got the news regarding the loss, it hardly phased me. As I considered what had happened, all the loss that was involved, the fact that we were attacked by spiritual enemies, I realized that God's work in me is continuing and ongoing. I have experienced loss of a much greater magnitude than this. I rejoice that it wasn't the loss of life or limb.

Many of you who have been through a lot of trials and tribulations know full well what I mean.

As I considered a presentation made by Pat Trueman at our summer conference, I realized that there are so many battles going on around us for holiness, purity, decency, life that my loss and ADA's loss was such child's play compared to what too many are going through - sometimes silently.

Consider these thoughts from Pat Trueman as he spoke on August 1. (Remember Pat as head of the Child Exploitation and Obscenity Enforcement Section at the Justice Department in Washington DC for over 8 years knows all too well about the ugly, destructive nature of pornography.)

Pat gave an explanation of how men sink into child pornography. It's a disgusting, terrifying scenario for someone's children!

In part, it is that the brain of the porn user is getting (inadvertently) retrained to find acceptable that which was once unthinkable. He gets accustomed to the variety of pictures that he was using. Online he finds a "friend" that will trade him his stash of child porn pictures for what he has. In order to keep a fresh inventory of child porn pictures, he goes out and acquires a new collection (with his own kids or neighbors).

And this is going on all the time and as recently as August 17 (I'm writing this on the 19th). From the Detroit Free Press: ..

*Nine men were nabbed over the weekend in a sting after allegedly having sexually explicit Internet chats with undercover agents posing as children. ...*

*They are accused of traveling to have sex with a child. Others also may be charged with sending pornographic images to undercover agents.*

*The men range in age from 24 to 53. One came from as far as Columbus, Ohio, while the rest are from Michigan. [Taken from Detroit Free Press, August 17, 2009]*

Another scenario that was discussed was in regard to the Internet. Both Pat and Steve discussed the implications of Internet use-age.

Pat talked about how young gals have a sleep over and take semi-nude pictures of themselves and post it on their Facebook or MySpace site(s). What they don't realize is that predators are continually scouring around for vulnerable young people. These predators are very skilled at communicating and building relationships.

Their communications can evolve into meeting the young person somewhere where the

teen is abused, used, captured and sometimes never found again.

There are things to be learned from these horrific, hellish trials of life!

God's word tells us that it is through trials and tribulations we are sanctified. Indeed, that is true. Yet, at the same time, we can and should avoid heartache and loss brought on by our own rebellion, foolishness and godlessness.

Conferences like the one we just experienced give great instruction and warning regarding the battle that satan is waging. There are great measures that can and should be taken to guard ourselves from the evil one and his deceptive ploys.

These conferences, too, serve as a great time for fellowship, building up, encouragement and being together with like minded friends.

# Pam Stenzel featured speaker for ADA summer conference 2010

For years we have been engaged in the war against pornography. Most all of us have been affected one way or another. ADA has warned, informed, prayed. We have also sought resources that would help us with our youth. Over all of these years the very best resource that we have found to speak into the hearts and lives of young people is Pam Stenzel. As you may recall, Pam's birth mother was raped and gave Pam up for adoption. A family in Grand Rapids adopted her. After receiving education at Moody Bible Institute and Liberty University, Pam worked in a crisis pregnancy center for 9 years. Through her vast experience, God prepared her to become an international youth speaker. Pam speaks to over 1/4 million students each year.

## Pam tells Her Story . . .

*You won't believe what I discovered during the nine years that I counseled girls who came into my pregnancy counseling offices in Chicago and Minneapolis. Most were worried sick about being pregnant. Very few were concerned about the venereal disease epidemic that is sweeping America.*

*Girls would come to my office and say: "Pam, if I had known this was going to happen to me, I would have made a different choice. But no one told me." I began to ask these girls: "What could we have told you? What could someone have shared with you, before you made your choice?" After all those years I realized there are a lot of students making decisions about sex*

*who have no idea what the consequences of their decisions will be. I am writing this so that none of you will ever again be able to say to a physician, a counselor, or to your future husband or wife: "Nobody told me. I didn't know."*

## Girls Hope They're Off The Hook

*Most teens who are having sex are afraid of getting pregnant. Girls come into my office for pregnancy testing, and when I tell a girl her test is negative, she gets a look of relief over her face, as though to say: "I'm off the hook. I'm not pregnant. Let me out of your office." Wait a minute! Have you been tested for syphilis, gonorrhea, herpes, chlamydia, trichinoma, vulvadema, urethritis, hepatitis B, HPV or HIV? You have a four times greater chance of contracting a sexually-transmitted disease than you do of becoming pregnant.*

*For nine years I've also had to tell hundreds of girls their tests were positive -- "You're pregnant." Immediately they want an easy, painless way out. I have to look at them and say: "Sorry. Your choices at this point are bad, terrible, and worse. You had a good choice before you chose to have sex. Now all of your choices are going to carry painful lifelong consequences."*

*Abortion, Anorexia, Bulimia, Suicide*

*There is no easy way out of pregnancy. Abortion is painful, destructive, and devastating. More than 80 percent of the women in our country who've had an abortion say that if they could go back, they would have chosen something different. Abortion isn't like going to the dentist and having a tooth pulled. I have counseled with hundreds of women -- five, ten, fifteen years after they had an abortion, who are still hurting physically, psychologically, and above all, spiritually. I've counseled teenagers with anorexia, bulimia, and depression -- including many who have attempted suicide because they had an abortion.*

*Parenting a child isn't an easy choice either. Eight out of ten single teenage girls who choose to parent their children will live below the poverty level for at least ten years. Most stay there the rest of their lives.*

*Nine out of ten will never attend college. These are girls who had goals, plans, things they might have liked to do with their lives after high school that they didn't get the chance to do because of their rash choice to have sex.*

## Guys Pay Dearly Too

*Guys are also facing very serious consequences for having sex outside of marriage. Lawmakers are now holding young men in this country responsible for having sex and getting a girl pregnant. The fact is, guys, it can cost you tens of thousands of dollars over the next eighteen years. The state you live in has the legal right to take away a sizeable portion of your pay from your job to support the child you fathered. If you're not yet working, you'll go into debt.*

*A young man I know who got a girl pregnant in Minnesota is being required by the State to pay \$350 a month to support his little girl. That's based on his current income working at Burger King. "I made a decision one night after drinking," he said, "that I never would have made if I had been sober. And I will pay for that decision for the rest of my life." This is a very serious responsibility, young men. You need to think about that before you have sex, because after having sex, it's too late.*

Russell Gortzig, 13, said his friend siphoned gasoline from a riding lawnmower and poured it on Gortzig. The teen said he held the lighter away from him, but a combination of the spark and fumes caught his shorts on fire.

“Skin missing all the way down to his ankle on the front and the back,” mother Linda McCrea said.

McCrea said the boys were trying to copy a stunt they saw on the video sharing Web site, YouTube, where a man in a banana suit lights himself on fire. She warned other parents to closely monitor the online activities of their children and wants YouTube to tighten its user guidelines. She believes YouTube is partially to blame for her son’s pain. ...



Here are the stipulations of the match grant put forth by our anonymous donor.



approved amendments to protect the institution of marriage within their state.

Quoting Peter Labarbera from Americans for Truth, [President] Barack Obama sure has a strange way of showing his much-touted support for traditional "marriage." On Monday, August 17, President Obama's Justice Department filed a legal brief against DOMA, the Defense of Marriage Act, which was signed into law by the last Democrat to occupy the Oval Office: Bill Clinton. Weeks before that, Obama's administration had defended DOMA, setting off a flurry of protests from his gay-lesbian-bisexual-transgender-whatever allies.

DOMA — which only Congress can repeal — passed overwhelmingly in 1996 with bipartisan consensus (a mere 14 Democratic Senators voted "No"). It protects states from being forced to recognize out-of-state "gay marriages." Its growing unpopularity among Democrats signals the near-complete moral collapse of the party of Harry S Truman, who surely would bristle at the Dems' current overwhelming support of abortion-on-demand and homosexuality as non-negotiable, litmus-test issues.

We keep hearing from the media about how incredibly smart President Obama is. But if he's so intelligent, shouldn't he know that you cannot rationally hold two contradictory positions at the same time? (Neither can God be both pro- and anti-sin.) Of course, the Obama-adoring media have allowed him to get away with his cynical double-game — telling voters again and again that he supports traditional marriage as they buried his opposition to DOMA and ignored his near-total subservience to the Gay Lobby.
