

Sears Sinks to Selling the Salacious *by Chris Johnson*



From their beginnings in 1886 as a mail order company, Sears, Roebuck, and Co. sent catalogs to their customers and relied on images to sell their products. By this method, Sears became the largest retailer in the U.S. and probably the first company to utilize the power of pictures in the selling of products.

I think it is safe to say that since it became a department store in 1925, Sears has also been recognized by most families as a respectable, family-friendly place to shop. They have provided families with baby pictures, glasses, clothes, appliances, and tools.

And now, pornographic posters for the special man in your life.

In June 2010, One Million Moms (an AFA outreach) rebuked Sears for selling a particular sexual poster under their "Gifts for Dad" section. Several days later, Sears acquiesced to One Million Moms' request that the poster be removed from the website.

A few weeks ago, however, American Family Association once more brought to our attention Sears' posters, this time in the "Art" section of the website. These aren't just posters of scantily-clad women. Some of them depict groups of people, lesbians and others engaged in sexual activities. Very little is left to the imagination.

Given its history, Sears, of all retailers, should recognize the persuasive power of images, yet this company has no problem marketing posters with full nudity and

overtly sexual themes including group sex and lesbianism.

Dr. Judith Reisman, an expert on the effects of pornography, had this to say via World Net Daily, "*Sears' management clearly agreed that pornography would conscript children and vulnerable adults as consumers. The Sears pornography adverts had to survive multiple administrative debates, redrafts and societal cost-benefit analyses before they got the green light.*"



Children cannot buy alcohol because their bodies and brains are corrupted by its toxins. Similarly, Sears' reckless distribution of pornography, of 'erototoxins' in the public space should be charged with deliberate brain damage - bringing the role of dopamine as a 'natural drug' to an American jury."

We ask that you would stand with us, AFA, and other decency ministries and let Sears know that you, their potential customer are not okay with their decision to contribute to the dissolution of our families.

One thing I am sure of: We need to get back to abiding in God and living under the authority of His loving Word!

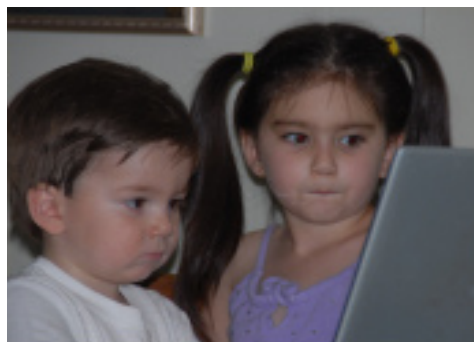

Government of the people, by the people, and for the people???

Can an honest nation call itself free when the opinion of one man can trump those of 7,000,000 of his peers?

Recently Judge Vaughn Walker announced that the wishes of the citizens of his state were to be ignored in the state's treatment of homosexual marriage. This judge's rejection of Proposition 8, which sought to amend the state's constitution to define marriage as between one man and one woman, is perverted on every level.

This ruling is obviously an abomination before God's eyes; it bastardizes the constitution; and it undermines the God-ordained definition of families.

Saying that homosexuality is an abomination in God's eyes always raises the hackles of some people. But I don't say it lightly or with my own words. You can take God's Word for it: *You shall not lie with a male as with a woman. It is an abomination.* (Leviticus 18:22) Pretty clear.

I know there are some who believe that the laws given in the Old Testament were cultural and tied to the times or the Old Covenant and they don't need to be followed, but this time God doesn't just say not to do it. He says it's an abomination. Now, I believe that one of the foundational beliefs of Christianity is that God is unchanging. By my logic then, if He said it's an abomination back in Leviticus, He probably hasn't turned around and said He's changed his mind since creation and its cool now.

Also, this verse is followed by a command against bestiality. I think that very few would argue with that commandment, why

should we throw out the preceding verse?

Moving on to the judicial flagrancy towards the Constitution.

Judge Walker appealed to the Activist Judges' favorite section of the Constitution: the 14th Amendment, Section 1. The article reads: *No state shall create or enforce any law which shall abridge the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.*

The answer to the Judge's argument is simple. No one is telling people that they can't get married. Only that they cannot marry someone of the same sex. We would also say they also cannot marry a horse, or a tree, or a railroad track.



There are no rights being denied those who practice homosexuality. They have the same right to a heterosexual, monogamous relationship that everyone else does.

Any rights being encroached upon are those of "we the people!"

Think about it. How can we stand on the words of Abraham Lincoln and claim that we are a "government of the people, by the people, for the people" if the opinion of one man, unanswerable to his constituents, can disregard the will of the citizens to whom he owes his power and position.

When the freedom of the citizens to amend the constitution of the state of their residence can be denied by the decision of one unelected official, we have ceased to be a representative republic.

As unfortunate as this case is for Christians and Americans who still believe in family values, it should concern every American who wants to maintain the ability to affect the outcome of public policy. In other words, any American who opposes the concept of an oligarchy. **This case may someday be a bullet point in the outline of the fall of America's Constitutional government.**

The third institution that Judge Walker violated so grievously is that of the family. Literally since the beginning of time, a family has consisted of a father, a mother, and their offspring. Judge Walker not only throws the voices of Californians in the garbage, he trashes the traditions and beliefs of every preceding generation.

Here is a direct quote from Walker's ruling. *"Children do not need to be raised by a male parent and a female parent to be well-adjusted, and having both a male and a female parent does not increase the likelihood that a child will be well-adjusted... The sexual orientation of an individual does not determine whether that individual can be a good parent. Children raised by gay or lesbian parents are as likely as children raised by heterosexual parents to be healthy, successful and well-adjusted."*

What's concerning about this ruling is that, if upheld by the courts throughout the subsequent appeals, this definition of family will dictate rulings for the whole nation for as long as she survives. Further, there would be nothing preventing future "redefinitions" of marriage to include the union of any and all combinations of people who wish to be married.

As if all that is not concerning enough, here's the kicker. It would be infuriating enough if this were just a liberal activist judge, but Vaughn Walker is about as biased as you can be in this case. He is homosexual himself! So the decision regarding homosexual marriage is not being made by an unbiased judge, but by a practicing homosexual!

In order to press on, we have to be able to provide for our staff. Without substantial strengthening, we will not be able to accomplish this area of need.

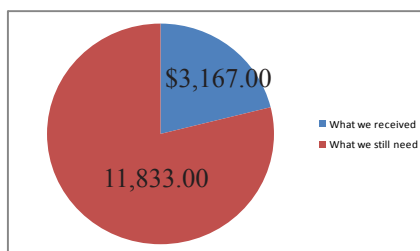

Dear Mr. Ostfield:

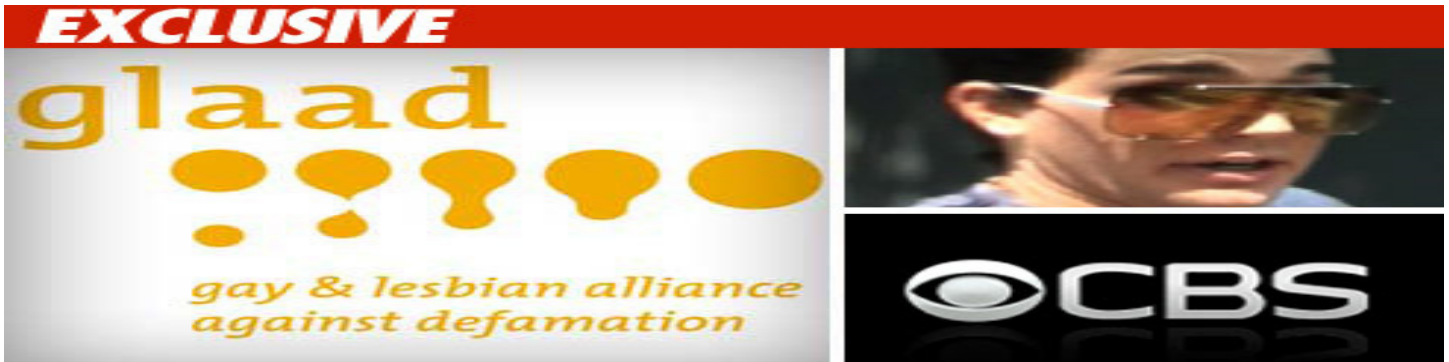

CBS has recently made clear which side the network is on in the Culture War

CBS President Nina Tessler has made a calculated decision to disregard the values of American families and increase the number of homosexual characters on her network's shows.

TV Guide reports that gays will be introduced or have enhanced roles on at least three programs: *The Good Wife*, *S#!t My Dad Says*, and *Rules of Engagement*.

This decision came on the heels of the revelation that CBS had received a failing grade from GLAAD (Gay Lesbian Alliance Against Defamation) for their treatment of homosexuality in their programming.

Tessler had this to say about the issue: "I'm very disappointed in our track record so far. We know and we will do better."

So because CBS will not allow themselves to have a negative rating from this organization, viewers and families around the country will be inflicted with one more source of indoctrination. Still more kids will grow up thinking that the entire history of civilization up to this point has been bigoted and misguided towards men who want to have sex with other men.

While those of us who are against homosexuality resent their agenda being forced down our throats, do we speak out and use our influence as does GLAAD? What a reflection on Christian lethargy that a homosexual group - representing a tiny minority of the population - exerts more clout in affecting change than does the Christian community.

It seems as if the best show on CBS may be *The Price is Right* or maybe the *Doodlebops*, but I would encourage you to neglect even these titans of television until CBS gets the message that GLAAD is the least of their worries. America's families do not want this ideology shoved down our throats. Ratings are the only language these networks speak.



What follows are GLAAD'S network ratings:

GLAAD Media Release

Broadcast Networks

* After three years in second place, The CW is now the top broadcast network with 35% of its primetime programming hours being LGBT-inclusive. This is the highest percentage ever recorded for a broadcast network, though it should be noted that The CW airs less primetime programming hours than the other four broadcast networks.

* ABC dropped to third place in terms of its percentage of LGBT-inclusive programming hours (26%). ABC received a "Good" rating because of the quantity and strong quality of its LGBT images.

* Fox ranked right behind The CW in its percentage of LGBT-inclusive programming hours (30%) but received an "Adequate" rating because of the stereotypical and defamatory nature of some of its content. NBC also received an "Adequate" because of the comparatively low quantity of LGBT stories (13%).

* CBS once again received a "Failing" rating with only 7% LGBT-inclusive hours of primetime programming, the vast majority of which came from its reality series.



Cable Networks

* In addition to MTV's groundbreaking "Excellent" rating, for the first time a majority of cable networks received higher than an "Adequate" rating. ABC Family (37%), TNT (34%), Showtime (32%), Lifetime (31%) and HBO (26%) all received "Good" ratings for the quantity and quality of their LGBT-inclusive original programming.

* FX aired a significant amount of LGBT-inclusive programming (27%), but often relied on stereotypes or problematic representations of the LGBT community.

* USA (4%), A&E (3%) and TBS (2%) all received "Failing" ratings for their lack of LGBT-inclusive images.
